OPERATING RULES OF THE 2025 Newmarket Credit Union Student Bursary

- 1. 3 lucky persons will receive an award of €700 (on a once off basis) towards their training and education costs.
- 2. The Bursary is open to all **eligible students** who intend to continue in education at: 3rd Level College University College of Further Education or Apprenticeship.
- 3. Applicants must have completed their Leaving Certificate in 2025 and
 - (a) Be a member of Newmarket Credit Union, maintaining a minimum shareholding of €10.00 and
 - (b) Live or attend a second level school within our Common Bond Area and
 - (c) Have joined the Credit Union on OR before the 31st May 2025 (if not living within the common bond)
- 4. To be in with a chance to be one of this year's lucky recipients, **Applicants** are required to complete a short **Application Form** available at the:

Credit Union Office Newmarket or Sub Office in Boherbue or Website at www.newmarketcu.ie.

- 5. Closing date for applications is close of business Friday 5th September 2025
- 6. Only **one Application** per member is allowed
- 7. **Winners** are chosen by a <u>simple draw</u> conducted at the September meeting of the Board of Directors. The decision of the board of directors will be final.
- 8. The winners will be notified by phone.
- 9. The names of the winners will be displayed in the public offices of the Credit Union, on the Credit Union website and social media pages and published in the press.
- 10. <u>Proof that the student is pursuing his/her education will be required BEFORE PRESENTATION</u>
 OF AWARD.
- **11.** Where the student wishes to defer their further education, and thus defer their bursary, this can be done for up to one-year. Proof will be required the following year in order to release the

deferred bursary. In the event that the deferral is extended or further education is not ultimately pursued, the bursary will be awarded to another applicant from the year that the original bursary was originally drawn. This may be a contingency winner drawn at the same time, or a subsequent draw from the unsuccessful candidates at a later date.

12. The credit union reserves the right to amend the rules of this bursary competition at any time.
